I refer to your email which you sent into us last week.

It should have been sent this message last week and we apologise for not getting this to you sooner so you could consider before any meeting. The content of the e-mail is set down below.

My intention was to go through in detail with you my opinion on all your Employment Tribunal and Employment Appeal Tribunal proceedings, following the termination of your employment in 2010, at our meeting on the 11<sup>th</sup> July 2013. However, I appreciate that you would like clarification of the issue in writing. I see that you have particularly focussed on two issues, as set out in your email of 27<sup>th</sup> June 2013 and will address these in turn.

With regards to the first issue, I do not believe there are any arguable grounds of appeal against the Employment Tribunal judgment.

As regards the second issue, in terms of the legal case that you finally took to the Employment Tribunal, in respect of unfair dismissal and direct discrimination, after withdrawing and/or not proceeding with any complaint of indirect discrimination or a failure of your employer to make reasonable adjustments. I cannot identify any error of law or ground of appeal in the Tribunal's judgment on the complaints that were argued in front of them. In addition, the fact that you did not lead any evidence about comparators and the fact that you did not put it to any of the witnesses that your dismissal was on the grounds of disability, has also led me to the opinion that there is no error of law, or grounds of appeal, based on the case that you argued before the Employment Tribunal.

My assessment of your case has taken longer than expected, due to the fact that I had a number of discussions with colleagues and practitioners to see if there was any avenue that could be taken to try and salvage the position that you found yourself in, after having been forced to take on such a complicated case yourself. I apologise for

not making you fully aware of what has been going on in respect of my attempts to try and salvage your position and I did not fully appreciate the stress and anxiety this would cause you, which was absolutely not my intention.

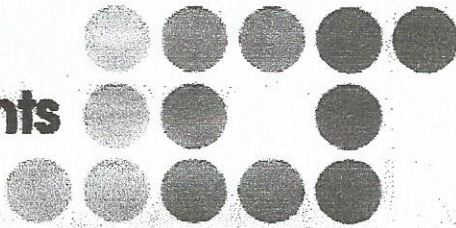

Thank you for your correspondence dated 23 March and 1 April 2015 which I received on 7 April.

I have read the material you sent me but I regret that I am unable to become involved in matters relating to employment judges.

My role as the Judicial Complaints Reviewer is to provide a free and independent service to anyone who has had a complaint about the conduct of a judicial office holder (judge, sheriff or justice of the peace but not employment judges) considered by the Judicial Office for Scotland (JOS) and who is concerned that the Rules may not have been followed. The JOS is required by law to consider complaints using the Complaints about the Judiciary (Scotland) Rules 2013. Once that process has been completed a complainant can ask me to investigate whether the Rules were followed.


My remit is limited to checking that the Rules have been followed and making any appropriate representations to the Lord President. I cannot require a complaint to be reinvestigated or overturn a decision. Nor can I obtain compensation, apologies or other redress. I can however make referrals to the

Lord President where I find the Rules have been breached so that he can consider what action may be required.

Complaints about employment judges are handled by the Employment Tribunals Service in Scotland. I see that you have already made a complaint and had it considered by the President of the Tribunals Service. Unfortunately there is no provision for independent review of the handling of such complaints. My predecessor raised this matter with both the Lord President and Scottish Government but I am not aware of any progress in this area.

I realise that my reply will be a disappointment but unfortunately there is nothing further I can do. I hope however that the above is helpful.

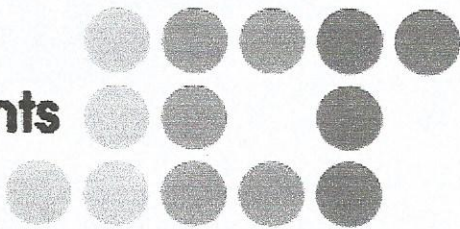

I apologise for not responding sooner to your recent telephone message in which you raised the matter of your complaint about Lady Smith. I was awaiting some additional information from the Judicial Office for Scotland (JOS) and I work only one day per week at present.

I understand from Ryan Gare, JOS, that you made a complaint about Lady Smith in 2012 and that it was dismissed in May 2012. However, I have not asked to see the relevant papers. As noted on my website I do not consider complaints that have been closed by the JOS more than 4 months prior to a review request being made to me unless a complainant provides exceptional circumstances for the delay. 


constituency MSP who looks to be either Sarah Boyak or Angela Constance.
